Highlights from the January Meeting:

The meeting was called to order via Zoom at 7:32 pm by club President, David Spoelstra, N9KT. There were 37 in attendance. There were no new hams present. Gary, W9ST, was attending his first IRC meeting. Also, Patrick Asher, was recognized as a new member to the club. Patrick is not a ham yet, but planning to test soon. David reminded those present that club dues are due now. He also spoke about other ways members can benefit the club, such as the Kroger Plus program, paying their ARRL dues through the club with the "Club Commission Program", and designating the IRC as the recipient of their RMD distributions, since the club is a 501(c)(3) charity.

David announced that there would be a club sponsored VE test session tomorrow (1/13), as there is every month, except for May, on the second Saturday of the month at the Salvation Army EDS Facility.

Next David introduced our speakers for the evening, Rich Moseson, W2VU, and Jose Castillo, N4BAA. Rich is the editor of *CQ Magazine* and Jose is the manager of *CQ's*

Worked all Zones (WAZ) Award program. Rich started off by stating that *CQ Magazine* has been having significant delays over the last few months. He is hopeful and optimistic that things will improve soon, but has no time table for this. He said that the financial problems affecting the magazine will have no effect on the contests and awards since they are independent from the magazine and self-sustaining. Rich said he has been the editor of *CQ* for 24 years. Before that, he held various positions with the magazine. He had also worked with CBS News and other journalistic endeavors. He said *CQ Magazine* has been around since 1945, that it came from *Pacific Radio Magazine* that started in 1917. He said the magazine has been involved with contests since the 1930s. The WAZ award started in 1934, and is the second oldest award in the hobby. Jose is an ambassador and mentor for the WAZ program. He said that WAZ is not dependent on country boundaries, etc. He also gave some tips on how to work specific zones.

The formal meeting adjourned at 8:30 pm.

NEW STATE QSO PARTY CLUB CHALLENGE

For the past several years, the State QSO Party Challenge (<https://stateqsoparty.com/>) has re-invigorated interest in the various State QSO Party contests. Starting this year, the State QSO Party Challenge organizers (of which our own Mark Musick, WB9CIF, is one) are starting a State QSO Party Club Challenge (SQPCC). The SQPCC scoring will be compiled from individual SQP Challenge entries into <https://3830scores.com/> which include a club name. The SQPCC will only include individuals who have qualified for the SQP Challenge (submitted logs for at least 2 State QSO Parties from the “Approved Contest” list each containing at least 2 contacts).

When submitting scores to the 3830 site, our club won't show up in the drop-down list, so in order for scores to be credited to the Indianapolis Radio Club, we will need to select “Other” from the drop-down menu and manually type in “Indianapolis Radio Club” for the club name. If enough of us do this, our club can be added to the club list.

IN PERSON TECHNICIAN CLASSES COMING UP

There are two Technician License classes coming up in Central Indiana:

1. Technician classes will be held at the Greencastle EOC on Saturday, January 20 from 9:00 am to 2:00 pm, and on Saturday, February 3 from 9:00 to noon, with testing following. Contact Carl, KC9VRA, at cwknapp51@yahoo.com for details.
2. The McKenzie Center will host FREE training classes for Amateur (HAM) radio operation on Saturday 20 January and Saturday 27 January at the McKenzie Center for Innovation and Technology, 7250 East 75th Street, in Indianapolis.

The Saturday sessions will start at 9:00 AM local time. The session on 20 January will run until 4:00 PM with a break on your own for lunch, and the 27 January session will end at Noon with license testing to begin after the class.

You will need to attend both Saturdays to cover all of the training material.

There is no cost for the training or testing, but you will have to pay a \$35 licensing fee to the Federal Communications Commission to receive your radio call sign.

- An Extra Class will start on January 9th and run through April 30th (16 weeks). The class meets on Tuesday nights, from 6:30 to 8:30PM. The class will use the ARRL Extra Class License Manual, Twelfth Edition. The class is free. The class will be taught virtually, using the Zoom software. Class size is limited to 25 students. This class will also be streamed live and recorded for later viewing on the W4EEY YouTube channel.
- A Technician Class will start on January 10th and run through March 13th (10 weeks). The class meets on Wednesday nights, from 6:30 to 8:30PM. The class will use the ARRL Ham Radio Technician License Manual, Fifth Edition. The class is free. The class will be taught virtually, using the Zoom software. Class size is limited to 25 students. This class will also be streamed live and recorded for later viewing on the W4EEY YouTube channel. Instructors will be Gary W4EEY and Dave KE4EA. - Another free, weekly Extra Class licensing course on Zoom will begin on Thursday, January 18, running through March 28. There will be 11 3 hour sessions starting at 6:30 pm Eastern Time. The sessions will be recorded in case someone can't make the time for one. Those attending should hold (or be studying for) the General Class Amateur Radio License. FCC NOTICE

Bulletin from ARRL reports FCC is proposing licensing fee (thought to be \$3) for licensing and inspection activities, see March QST. Comment may be filed with FCC until April 1, 1954.

[This \$3 in 1954 would be equivalent to \$33 to \$35 in today's money. It appears this fee was to be submitted with any application or renewal. Unknown if this was approved or how long it was in effect if it was approved. - KJ9B]
